#### DRUMMONDVILLE'S HAD ENOUGH

(Submitted March 11th, 2016)

We became activists in Drummondville. Some of us are still there, some are now in Montreal. Our activism began "in a region" and has continued or will certainly continue in an "urban center" since there isn't a University where we live or used to live. We don't care how you call these realities. "Urban center", "large city", "metropolitan city", versus "region" or "association outside Montreal", it doesn't really matter to us. What does matter is that the way the debates surrounding montrealcentrism are taking place is very frustrating. We either vigorously deny it, push it aside, or manipulate it for our own political agenda. The reality is that montrealcentrism exists, and that it's more insidious than you think and that it's up to activists in the regions or from the regions to bring forth change and solutions. No need to speculate between people from Montreal. This text won't present any solutions. This text isn't here to make you feel good or to be appealing. This is the expression of an overload, and it aims to show you our reality. Maybe if you listened for once, you could understand.

Being an activist in a region means having an Executive isn't always full, with lots of new people, with a mobilization committee that brings together exactly the same people (if they bother showing up), and the same goes for the rest of the committees. It means having to constantly struggle to have a full Executive and active committees while also having to think about who's going to pick up the baton. Because when you do finally get someone to get involved, they're often in their final year.

Being an activist in a region means to be perpetually informing the student population that their student association exists. It's a permanent battle to show what your union is for. Before thinking about an action plan to join in a national campaign or to defend your members' rights, you have to mobilize for your election GA, otherwise you won't have an Executive Council and you can't go forward. It means being confronted with students' questions, contempt, disinterest and even disgust when you're mobilizing. But we draw our motivation from the rare but relevant discussions with students we don't know but who seem interested. It also means having to inform a student population of 2500 people when you're a group of 5-10 people on a good day.

Being an activist in Montreal means Executives that are often full, where we can have discussions on how to best open it to more members. Open Executive? Executive by committees? Adjunct or deputy positions? All damn good ideas. We have to open democratic spaces, but when you have to bend over backwards just to have a full Executive, this debate isn't quite as stimulating. It sounds much more theoretical than anything. It also means having diverse and active committees. Hey, at Maisonneuve, there are over 12 active organisms! That's more active members than we had or currently have at Drummondville.

Being an activist in a region means that you need a car to meet the closest neighbouring student union because it's a 45 minute drive away. It means having to pay for gas to attend meetings. It means not really having any associations with whom we can share our realities because we're not in the same administrative region as the MASSE, our current regional council. The associations from the regional council we should be in are even further and have realities that our different from ours. It means knowing that, in the end, we're pretty isolated.

Being an activist in Montreal means being able to meet a phenomenal amount of other associations without even have to change public transport services. It means thinking that Marie-Victorin is too far to go and lend a hand because the metro doesn't reach it. It not only means having associations with similar realities nearby, but also the capacity of seeing them on a regular basis.

Being an activist in Montreal means being able to call a General Assembly one week after losing quorum because you know that activists from neighbouring associations can easily come over to lend a hand. That's just swell.

Being an activist in a region means knowing that ASSÉ, in the end, is far from you. Going to the office, even when you're on the national team, isn't easy. It means knowing that you're lucky if an instance takes place in your town, and that every other time it'll be in Montreal where you'll have to deal with sleeping on cold floors and driving back from Congress exhausted. I was only going back to Drummondville, never mind St-Félicien. We must never forget how impressive it is that they're there every time, and the level of dedication that requires. It means not being aware of all the national issues because you don't have the time to look into all the local, regional and national struggles while keeping your own association alive. When you arrive in Congress, you don't always understand everything very well, but you make do with what you have. Your delegation is smaller than other associations'. Sometimes you're even alone while others are stacked together in a group of ten with the observers they brought with them (that's more than our mobilization committee...). It's of course ideal that more people participate in the instance, but let's admit it, it's pretty intimidating. And it means that the bigger associations monopolize the speech turns. It simply isn't possible to take as many speech turns when you're alone in your delegation. And often when you're more than one, you're with newer activists who are still too shy to speak in Congress, shyness that's only reinforced by the way you ignore them or by the faces you make. We see you. So the same message is often repeated and your mandates aren't heard. Long live democracy. It means having to endure the Congress without taking breaks that are voted by the other associations, because the so-called debate is more important than your mental health, and having to be there the next morning, regardless of the time at which the Congress adjourned the previous day because you don't have a team to replace you. Finally, it means having to leave the place you call home so you can continue studying and organizing.

Being an activist in a region means arriving in Congress less prepared than the Montreal associations because we get less information and couldn't meet with the other unions from our region because of the distance, and often the realities of the nearby associations are very different from ours. It also means being looked down upon, especially when we're still in Cégep, by

associations having more experienced delegates or by associations having "a better reputation" in the national association or in the student movement. It also means not being listened to by other associations in Congress for some obscure reason. It means contempt, or being erased by these delegations. It means being spoken to in a paternalistic tone to make sure that we understand the realities of Montreal. No, we don't know the Montreal realities, but not because they're too complicated for small regional associations, but because no one tells us anything about what's going on. And then we look soft because we stay in our corner and not get involved in these projects. We're excluded and forgotten when things go well and when things go bad, we're accused of not joining in.

Being an activist in a region means not having as many leftist groups around you, if there are any at all. Conflicts between extreme Left groups seem ridiculous to you. Maybe you don't agree on self-management with the Maoist in your Cégep, but it's only an individual debate. There aren't as many protests, and when there is one, you can be sure you took an active part in it. It means not having any kind of counter-discourse in the media other than what comes out of the mouths of your comrades. It means accepting that Québec Solidaire is the farthest Left organization in your region. It means having to deal with the prejudices of people who are afraid of your association's office because you're not "normal" enough for these people.

Being an activist in Montreal means that there's an effervescence of leftist and even radical leftist groups. When you finish unpacking your last box, when your Internet's finally plugged in and you try to see which radical Left group is in your neighbourhood, you get a little dizzy. All this? You realize after a moment that for some reason, all of these groups barely work together at all and there's tension between them. You at once start understanding the dynamics of the shadow politics. When you're mobilizing in Montreal, you're not starting from the same square. You don't have to fight as hard against mass media. The Left succeeded in creating a counter-discourse, and although it's weaker than we'd like, it still acts in your favour. And you can go further from there.

Being an activist in a region means being far from the "action" and the information. It means not having as many resources as in Montreal. It means willing to get informed and to learn on your own, but that the issues and realities are hard to reach. And also, resources are a lot fewer than if you were in Montreal. Realities are different, and the resources that could make a difference aren't always there. We don't have a big library where we can find the information that could deepen our understanding on a certain subject. We have few groups, if any, with whom we can identify and organize and get informed. Alternative media isn't a part of our culture, and even if you do follow it, the "quality" information you may find is smothered by mass media. Of course we have access to Internet and all the information we can find there, but for that we need to know what to look for, and above all else you need the will to learn, which isn't implanted in people's lifestyles.

Being an activist in a region isn't just negative however. It means knowing that we have a much bigger impact in our communities. A 50 person demo? It's enough to paralyze the town and to get all the local media talking. It means having greater autonomy, it means being able to

develop our own reflections far from Montreal's sectarian conflicts. It also means getting to know just about everyone at your Cégep as you mobilize. It means truly feeling like a student community, even if some people will run away from you knowing that you're on of the people from the association. It means having a constant feedback from your student population. You've gone too far in your political positions or your mobilization? Don't worry, someone'll talk to you about it in class, at the gym or the cafeteria. It's grueling work, but oh so essential. It means being side by side with the same comrades day in and day out. It's not always easy, but at the end of the day, you become a family and these people help you through the rough patches. These friends will be there if you need them and you'll always be there for them.

And montrealcentrism in all this? It's when you don't bother to listen to criticism brought by associations on how we do things. It's when you don't see the importance of ASSÉ in the development of regions. It's when you completely ignore the participation and transportation costs when it comes to the dues increase. It's when you adopt a superior, even elitist attitude when it comes to smaller associations and when you think you have all the answers. It's when you come to the regions not to help, but to push your political agenda when we're not there yet, and spoil weeks of mobilization and then you have the gall to call us soft on your way out. It's when you hand out your pamphlets and put up your posters without even discussing it with the local association when we have no idea what your Spring 2015 is and we'd only like to know more. We could've been interested, but we simply didn't understand. It's thinking that the regions are going to follow a general strike campaign at the same rhythm without even being informed. It's blaming tourist activism when sometimes we genuinely ask for help, while you invite yourself over. It's not bothering to show up at a national demo in Quebec City but expecting eight buses from the regions to come to a demo in Montreal called a week in advance. It's simply thinking that your privileged reality comes before ours and that you know what's good for us better than we do. It's to transmit your reflections exclusively on platforms consulted by people in Montreal. If this is what you think, take two minutes to ask yourself if by combating domination dynamics that must be forever destroyed, you're not creating new ones. Finally, montrealcentrism is when you leave the region you started organizing in and you begin to forget where you came from and that there's a whole other something outside the metropolis.

We don't want your pity. We only ask that for once, you listen a little further than the Hochelaga archipelago. Where people also struggle every day with all their might for the same causes as you. In a different way, of course, and at their own pace, but still the same causes. We'd tell you that it's high time that we lend each other a hand and take up the struggle once more before it's too late.

# MARIE-ÈVE TREMBLAY-CLÉROUX'S LETTER OF RESIGNATION FROM THE ASSÉ TRAINING COMMITTEE

(Submitted February 23rd, 2016)

Comrades and friends,

It's with regret and sadness that I announce my resignation from the Training Committee.

It was with a feeling of enthusiasm that I ran for the Training Committee last April in order to prepare the mobilization, and the strike, during the autumn against austerity. Yes, we were collectively exhausted from the spring, but I had hoped that we could start it all up again and build solidarity with the most mobilized workers.

This autumn was a failure. A failure that doesn't belong to the national team, but to ASSÉ's structural capacity to successfully build a social struggle. And consequently, on its capacity to question itself. Founded in 2001 by the few combative student associations in Quebec, ASSÉ has been a powerful vehicle in a struggle against the Quebecois State. In fact, before being a union aiming to defend the rights of the student population in Quebec, ASSÉ has been a space, an environment, capable of bringing together a radical left that is critical of the State and of Capital.

At least, that's the ASSÉ that I remember. But my return to ASSÉ Congresses last weekend confronted me with a harsh reality. Political tension, which can be a powerful vector for internal cohesion, now paralyzes our national organization because it can no longer be properly heard. In this context, I doubt that ASSÉ can still be a vehicle that can effectively fight against neoliberal policies. Of course, Congresses are no picnic. Of course, direct democracy can take time. This isn't the topic of my criticism.

I'm not resigning because of the tense political climate, or because of conflicts within the committee or the rest of the national team. I'm resigning because I don't believe that my energy is well invested in an organization whose practices no longer align with my values. In this context, I don't see how I can continue to be involved in the national team.

Comrades,

With this letter, I hereby submit my candidacy for ASSÉ's Secretary of Academic Affairs. I am currently a undergraduate student in anthropology at the University of Montreal.

I began my involvement at SOGÉÉCOM (Collège de Maisonneuve) where I held the position of Assistant to Internal Affairs and helped the local Mobilization Committee. This activist association to which I owe my first contact with the student movement also served as a vehicle towards my national involvement. During the summer following the completion of my college degree, I was in contact with several people who were on the national team to become familiar with the different instances. Comrades,

It must be recognized that 2015 wasn't an easy year. Two strike movements left us reeling with uncertainty, tension, repression, and exhaustion. Little good appears to have come from the austerity campaigns we held at ASSÉ.

However, I think it's important to underscore its formative aspect. For me, and for many other students, the struggle against austerity was like activism school. It meant learning to do one-on-one mobilization, to design GA leaflets, and to make banners with whatever we had at an arm's length. It meant overcoming my shyness and speaking up during meetings, during classroom announcements, in assemblies, and to realize that I was at least as relevant as my male comrades. It meant many things, but above all else, it meant realizing all the work that's behind every "Be it therefore resolved" adopted in GA. To transform the principles voted in Congress into local realities is a politicization effort that doesn't stop after the high seasons of mobilization.

This is what drives me to believe that despite the important reflections we must have about our recent campaigns, it's also time to roll up our sleeves and get back to work, because the economic elites and the State won't wait. Modulating University tuition fees, adapting education to private sector interests, deteriorating working conditions in education... but seeing activists mount pressure against ancillary fee increases, protesting against military recruitment on their campuses, or keeping their associations' head over water despite demobilization, I'm confident that we can overcome. It's with this will to support these incessant efforts that I hereby submit my candidacy as ASSÉ Coordination Secretary.

If I may introduce myself, I was an activist at SOGÉÉCOM, Collège de Maisonneuve's union, for about a year and a half. I first got involved with the Women and LGBTQ Committee, then the Mobilization Committee and the Executive as Coordinator. I took a break from full-time studies at my beloved Cégep during the winter of 2015. That brought me to run for the elected team at ASSÉ, first as Secretary-General of Central Council, and then this year on the Social Struggles Committee and the position of Secretary-General of the Coordination Council. A flagrant example was during the recent Women's Congress, where for the first time I saw the vast majority of attending delegations take speech turns. Solidarity, to me, means reminding ourselves that our struggle isn't only about white men. We therefore have to ask ourselves, why are they always at center stage?

Finally, here are a few ideas that I have for my mandate:

- Formalizing the ASSÉ national team's training, primarily through workshops and transition documents that are available to everyone.
- Putting in place feminist squads during instances, which would intervene in the case of problematic situations and to ensure that the instances remain a safe space.
- Continue sending the Executive Council's monthly report, and include a section on the financial situation, and make sure that the Committees also send out summaries of their activities.

With apprehension also because, even if my mind and motivation are set, my personal situation is difficult at this time and I don't know if I'll have the ability to meet the upcoming challenges while remaining intact.

On the other hand, I'm running with joy, because I believe in ASSÉ. I see ASSÉ as a vehicle for struggle and for developing political awareness and that is essential to the student radical left in Quebec, and the thought of giving back to it brings a smile to my face. The scope of the task is imposing, but it's also stimulating.

My activism began in Drummondville where I was principally External Affairs Coordinator, but also natural sciences representative (before realizing that that position was more for organizing parties than politics), and also Information Coordinator before realizing that my inaptitude with computers and my visual disability limited my capacity to create pamphlets and posters. My experience in Drummondville taught me the fundamentals of activism, of organizing protests, of preparing for Congresses and for doing one-on-one mobilization. It also taught me the importance of the national team whose support allowed us to vote a one-day strike on April 2nd 2015, a first since 2012.

I was then elected to the national team on the Social Struggles Committee. My experience on the committee was rather lukewarm. On one hand, the team we were was certainly pleasant and certain comrades are now my close friends. On the other hand, it made me realize several things. If I initially wanted to be a part of the Social Struggles Committee, it's because that's the role that seemed closest to my former position as External, for which I had a particular affection. Regarding external relations, it's our pleasure to announce that the Cégep d'Alma has affiliated to ASSÉ by referendum at the end of the month! # ASSÉ LEGAL COMMITTEE REPORT

(Submitted April 14th, 2016)

Having a reduced workforce since the beginning of the year and the Committee members having other important personal obligations, we've limited ourselves to doing the more usual and administrative tasks since the last Congress: answering e-mails, following up with various groups of arrested people, helping and supporting newly arrested people, distributing money from the Arrest Fund, accompanying people to Court, etc.

We've also worked on a motion that would modify the Committee's mandate (see Appendix 1 of the preparatory booklet) that we hope will be adopted at the upcoming Congress and would reflect the Committee's current practices and guide our decisions better. We've also cleaned up the Committee's old files (redacting the names of people who receive the Committee's financial assistance, updating funding request documents, tidying up old files, etc.), so that the next Committee may start on the right foot.

We're overjoyed by the many candidacies the Committee's received and we hope that the next team will be able to go above and beyond the more usual and administrative tasks and work on more activism-oriented projects: developing workshops, the Wiki, a project for archiving and documenting verdicts and Court decisions in collaboration with an attorney, etc. The next team will have to look into the Arrest Fund's finances, and eventually think of a fundraising campaign.

# AGECFXG'S SUMMARY

(Submitted March 8th, 2016)

# Demands: women, feminism and parenthood

 $AG\mbox{-}13\mbox{-}02\mbox{-}2014\mbox{.}19$  — AGECFXG adopts a position against xenophobia, sexism, homophobia and transphobia.

AG-01-11-12-19 – AGECFXG reiterates its feminist position, encourages alternating between men and women in speech turns and moves to immediately feminize all its official documents.

AG-A06-758 – AGECFXG adopts a position against the consideration of alimony for single mothers and fathers who are students in the financial aid calculation.

AG-A06-724 — For the promotion and accessibility of public daycares and for daycare schedules adapted to class schedules.

### **Women's Committee**

At Cégep Garneau, there's been a (non-mixed) Women's Committee for a long time, since at least the beginning of the 1980s. According to our permanence's memory, the Women's Committee has always been non-mixed. Fitted with their own room and often acting as a safe space, the Women's Committee is the site of discussion groups and debates on abortion, etc.

Over the years, the committee's had its share of highs and lows, sometimes intense, and was sometimes empty. Over the past 15 years, the times at which feminism was the most active coincided with the student mobilizations of 2005 and then 2012. It's worth mentioning that, in some cases, feminist activists preferred getting involved with the Executive while also organizing feminist activities, but it's sometimes difficult to bear the double burden of feminist and student organization (that is, feminist organizing within the Executive while being in a non-mixed committee while also being involved in different struggles). In conclusion, the Women's Committee is currently active and has been so since 2013 and has organized numerous awareness and mobilization activities (namely on consent, rape culture, the Polytechnic massacre, prostitution, cat-calling, etc.) every two weeks or every month. The more recent mobilizations have been around struggles against sexual assault, for feminism, etc. The Women's Committee also manages a Facebook page and has been confronted with an important antifeminist backlash. In 2014-2015, the Women's Committee was the most active of the entire student association.

## **Board of Directors**

Since 2009-2010, regarding the student association's Board of Directors (Garneau's Executive), women do not have equal representation. They represent about 46% of elected officials, although this number is difficult to calculate because of the high turnover rate within the Executive (the number should be above 46% if we exclude the empty positions – so about 50% - and it's been above 50% for over a year). However, in 2011, women represented 63% of the student body. Finally, the position of coordinator has been occupied by a woman over 60% of the time since 2009.

### **Student movement**

It's worth mentioning that female leadership within the student movement has been very present around Quebec City since 2012 (namely within the FRAQ-ASSÉ or the ASSÉ Executive). Regardless, that hasn't always translated into performative feminist demands and gender inequality is still present, namely with "false feminism", "patriarchal ambiance", and gendered division of activist labour. Nonetheless, the question of activist leadership is still (and always) relevant. Female leadership not only allows for a redistribution of powers and responsibilities otherwise appropriated by men, but also to change the organizational and activist culture of student associations and of activist circles (Maxim Fortin, Rouge de colère, October 2012). Finally, we can state that the renewal of feminism in the Quebec City area is probably due to the renewal of the student movement itself or to ASSÉ's leadership in the student movement around the Capital.

# **AFESH-UQAM'S SUMMARY**

Whereas the seventh principle and criteria 4 and 5 of the ASSÉ Bylaws are to be respected, Be it therefore resolved that ASSÉ respect its Bylaws;

# **Recent history of feminist struggles at AFESH**

If there've been feminists who have been members of AFESH throughout the years, there hasn't always been a spirit of collaboration. A complete history that can be found on the web journal Françoise Stéréo: http://francoisestereo.com/uqam-champ-de-bataille-histoire-incomplete-desactions-feministes-sur-le-campus/. The bylaws include a Women's Committee, which has been inactive for years. Generally speaking, feminists prefer to organize within affinity groups rather than in the association, due to the flexibility and autonomy that come with this model. This is possibly due to bad previous experiences in other student associations. If they submit a request, we can fund their projects, if need be.

Most of our mandates concern reproductive issues or of women's sexuality in a patriarchal system. This domination produces a reproduction of sexual inequality, which feminists seek to counter. Even (pro-)feminist men have committed assaults. The sexual division of labour, leaving women to handle invisible tasks (care, logistics, etc.), is also a theme we touch upon. Our feminist perspective is materialist, which some support to queer and LGBT struggles. Many gaps in our principles, namely regarding students who are parents, could be addressed. Furthermore, we observe that our mandates are adopted in a specific effervescent context which makes them relevant and performative. The subsequent actions allow for a definite impact on people's lives.

Recently, our struggles have centered on sexual violence. For example, several sexual assaulters have been excluded from positions of power, like Ivan Brika (from the band Mise en Demeure), Frank Lévesque-Nicol (then-Coordination Secretary and masters student in sociology with a concentration in women's studies), and Valentin Bellec (sociology student and activist with Spring 2015). We noticed that since the student movement constantly includes new people, sexual assaulters take this as an opportunity to reinsert themselves in these spaces against the will of the survivors. Whereas AFESH has mandates to support feminist initiatives after sexual assaults and to support the survivors,

Whereas it is necessary to empower activist collectives in the transformation of society and to abolish rape culture,

Be it further resolved that it be done in collaboration with feminists.

November 25th, 2013

Be it resolved that CLASSE publicly condemn the sexist, homophobic, ageist, fat-phobic comments held by several comedians during the June 18th show since this discourse and the ideas behind them contravene the basic principles of the organization.

Be it further resolved that in the future, CLASSE refuse to associate itself with any event without previously consulting its members, particularly if it can expect that the discourse at the event may contravene the basic principles of the organization.

Be it further resolved that CLASSE accept 50% of the profits for Juripop anyway, and that part of this money be handed to the Women's Committee.

June 19th, 2012

Whereas AFESH-UQAM has often presented itself as an organization in favour of feminist struggles;

Whereas that, contrary to popular belief, AFESH-UQAM has rarely ratified or adopted truly feminist positions in its General Assembly;

Whereas that this lacking has gone on long enough;

Whereas that feminist struggles must be pursued and intensified for AS LONG AS IT TAKES!

Be it therefore resolved that AFESH-UQAM reiterate its solidarity with women's struggles, feminist struggles, LGBT struggles, queer struggles, intersex struggles, and the struggles related to specific oppressions related to the intersection of multiple oppressions, namely related to class, national origin, skin colour, religion, or sexual orientation;

Be it further resolved that AFESH-UQAM condemn all sexual violence and all non-consented relation, particularly those done towards women;

Be it further resolved that AFESH-UQAM reiterate its support for practices encouraging, within its structures, the disempowerment of men, and allowing for a true equality between the sexes that's not only on paper; such as non-mixed caucuses, man/women alternating in speech turns and equal distribution of different tasks between the sexes;

Whereas initiation/frosh events are sexist, racist, colonialist, classist, homophobic, transphobic, and lesbophobic (for example, the communications frosh in autumn 2013) also demonstrates the necessity of feminism in student spaces;

Whereas male sexual violence, which are a part of a war on women, severely hinders the participation of women in mixed collective struggles including the student movement and that's unacceptable for female activists to be attacked by their own comrades;

At AFESH, most feminists choose to not organize within the structures of their faculty association, preferring affinity groups or the feminist movement, for various reasons. Therefore, this isn't an exhaustive list, not including for example the actions of the sociology or sexology feminist committees. In order to help with the empowerment of entire groups of women rather than only a few women in leadership positions, we've decided not to appropriate them by including them in AFESH's actions.

### **Basic**

Majority of women on the Executive (but AFESH is composed primarily of women)

- Both permanent employees are women
- Alternating speech turns between men and women in all instances
- All communications are feminized
- Publicizing of feminist collectives' events

## Feminist initiatives

- Frequent mood-watching during GA's, including a cell phone belonging to AFESH so that mood-watchers aren't harassed afterwards.
- Menstrual cups available at low cost at Café Aquin
- Frequent "feminist" agenda items during General Assemblies
- Purchase and distribution of large quantities of condoms and lubricant

## Annual campaign against rape culture

- Anonymous fund for supporting feminist actions following sexual assault
- Possibility to suspend funding of a collective which includes a sexual assaulter who is not collaborating with the survivors, giving full decision-making power to feminists
- Two explanatory posters and a series of "bubbles" directly addressing passerby's.
- Posters on consent are always available on the mobilization material table in front of the office
- Popular education on the topic of sexual assault on the Facebook page
- Presence on UQAM's Policy 16 on sexual harassment's revision committee
- Support for initiatives seeking to exclude sexual assaulters, at the survivor's request
- Support for any feminist initiative against harassment at UQAM or that is critical of Policy 16, which often leads to media coverage

• Funds dedicated to maintaining the committee for the revision of Policy 16, which was threatened by UQAM's restructuring plan

# Support for the feminist movement

- Financial support for the Montreal Sisterhood, for two publication initiatives by sexual assault survivors, for the Edgy Redux Festival, for an activism 2.0 initiative which includes a workshop on cyberfeminism, for a queer and feminist library, a \$1000 dues refund for the women's studies student association, financial support for the feminist magazine Féminétudes, for the group Fillosophie, for an LGBT suicide prevention project, for LGBT correspondence, as well as other anonymous projects.

Whereas the seventh principle and criteria 4 and 5 of the ASSÉ bylaws are to be respected; Be it therefore resolved that ASSÉ respect its bylaws; Be it further resolved that, in that sense, AFESH call upon ASSÉ to consider as non-member the student associations that don't have feminist principles, practices and demands, if they don't pledge to rectify the situation before the annual Congress.

Be it therefore resolved that ACSSUM demand a more gradual approach, starting for example with the withdrawal of voting rights and ending with the expulsion of the student associations in question." Adopted unanimously (adopted April 22nd, 2015)

• Whereas ASSÉ has adopted motion 6 (Be it resolved that AFESH call upon women in the public sector, which is composed primarily of women, to make this strike a feminist one, stretching beyond traditional unionism and refocusing the debate on the question of women's struggles against the State, which systematically deprives women of their right to strike through the Essential Services Act, which condemns women to be the domestic workers of all of society) in its February 21st-22nd Congress;

Whereas the RSÉ on September 26th-27th unanimously adopted motion 14 (Whereas women occupy a majority of public sector jobs and are therefore the first to feel the impacts of budget reductions; Whereas that cuts in the public sector increase the invisible workload of women; be it therefore resolved that the RSÉ condemn the sexist aspect of budget reductions and of the increase in job insecurity in the public and para-public sector, as well as the disinvestment in social services.)

Be it therefore resolved that ACSSUM bring a motion of censure towards ASSÉ at the next Congress in order to condemn its participation in the minorization of women's

issues in common struggles." (adopted October 13th, 2015)

## **Practices**

## Within the Executive:

- Executive currently composed of 7 women and 3 men. The positions with the highest number of responsibilities are occupied by women (for example, general coordination, treasury, etc.).
- The names of the positions are feminized.

### Communications:

- All communications with members are feminized, including ACSSUM's Bylaws.
- Invitations to participate in various feminist events, such as protests, are regularly sent to members.

# **During General Assemblies:**

- Members are required to feminize their comments when addressing the Assembly.
- Speech turns are done by alternating between men and women.
- A mood-watcher is elected when deemed necessary, for example during debates on sensitive subjects.

# Activities organized with the Women and Sociologies Committee

- Feminist "4 to 7's" are organized several times throughout the year in order to fund the Women's Committee and to promote feminist issues.
- Several conferences/discussions are organized every semester in the form of "Feminist lunch hours". Professors from all horizons are invited to present different feminist issues.

- Last year's feminist summer University at Université de Montréal was organized with the logistical and financial support of the Women and Sociologies Committee.
- Several workshops on different feminist regarding our department were organized, for example on the presence of female authors in our mandatory reading material.
- A project aiming to develop an index of female authors in sociology through a website (in the same way as what was done for women in political science) is currently being organized.

# **AECS' SUMMARY**

(Submitted March 18th, 2016)

### WOMEN RISING!

Several schools of thought, political ideologies, and societal debates are present in the student movement. Most notable are the working class' struggle, the labour movement, and national liberation, particularly in Quebec. But above all else, the issue that will have a profound and prolonged impact in our debates, political orientations as well as the political protagonists in the Quebec student movement is none other than feminism.

The appropriation of women's self-assertion spaces within the student movement is remarkable, especially when compared to the place they occupy in traditional political bodies.

Feminist content has occupied an important place in AECS' publications in the 1980s when a more radical critique of patriarchy was being heard. The condemnation of sexist inequalities and calls for women's mobilization were a regular sight in AECS' student press.

Important problems such as assault and abuse by male teachers are brought to light. Several articles condemn the administration's inaction on this issue and urge AECS' members to file complaints.

AECS' Women's Committee was founded in 1982 by and for female students. At the time, it had its own spaces. The issues it addressed were sexist education and publicity, rape, sexual harassment, domination dynamics, inequality and pornography.

The use of the feminine form in writing can be traced back to the 1980s and continues today. The practice of alternating between genders in speech turns started in 1982: during a General Assembly, the praesidium asked for a microphone to be set up for men and another for women.

These two pioneering practices, along with the inclusion of feminist demands in AECS' platform, demonstrate how equality between men and women has been at the heart of AECS' values for almost 40 ears.

## Our positions:

Be it resolved that AECS demand, in recognition of women's difficulties and in accordance with feminist ideology:

- Oral and written feminization in all educational institutions;
- <u>Daycare services in all post-secondary educational institutions:</u>
- That the opening hours of daycare services be aligned with class schedules;
- The implantation of nurseries for children under the age of 2;
- That the loans and bursaries program be adjusted according to the needs of student mothers, women, and single-parent families, in accordance with the actual cost of raising children;
- The development and implantation of women's studies departments in all cycles of post-secondary education;

Be it resolved that AECS demand that women have the right to control their own bodies. AECS underscores the importance of abortion rights and pledges to act in favour of women's right to choose with regards to pregnancy.

Be it resolved that AECS condemn any attempt by a legislative project, committee or any other structure that would criminalize abortion or that would legislate this issue in such a way that would harm the freedom of choice or access to abortion services.

Whereas the French language considers the male form to take precedence over the female form and that this consideration reflects the notion that women are biologically and intellectually inferior to men;

Whereas the feminine half of humanity is as important as the other half;

Whereas the first lines of Canadian Charter of Rights and Freedoms reads as such: "Whereas every human being possesses intrinsic rights and freedoms designed to ensure his protection and development; Whereas all human beings are equal in worth and dignity, and are entitled to equal protection under the law; Whereas respect for the dignity of human beings, equality of women and men, and recognition of their rights and freedoms constitute the foundation of justice, liberty and peace.";

Whereas the Universal Declaration of Human Rights states in its preamble: "Whereas the peoples of the United Nations have in the Charter reaffirmed their faith in fundamental human rights, in the dignity and worth of the human person and in the equal rights of men and women and have determined to promote social progress and better standards of life in larger freedom."

Be it therefore resolved that AECS support the Women's Committee in its demands to retroactively feminize all written documents produced by the Cégep de Sherbrooke.

Be it further resolved that AECS adopt a position against government's draft Charter, and that it condemn its sexism and discriminatory content, and that it actively fight against its adoption.

# **AESPEP'S SUMMARY**

(Submitted on March 30th, 2016)

Hello comrades,

At the last Congress, AFESH-UQAM submitted a notice of motion. This notice of motion concerned feminism, pertaining to the positions, practices and demands within ASSÉ. Furthermore, it directly targeted the student associations that weren't present at the Congress, or that didn't speak up, or that simply didn't have "demands, principles or practices that were 'sufficiently' feminist in order to meet the seventh principle". The targeted associations were called upon to submit a summary of their feminist demands, principles and practices through ASSÉ-Support before the Annual Congress, where the notice of motion would be discussed. Following the notice of motion, SOGÉÉCOM submitted a motion asking all student associations to produce a summary of their feminist demands, positions and practices which would then be sent out to ASSÉ-Support where all members could consult them. This is what AESPEP has done. We've produced our summary of feminist demands, principles and practices.

However, we would like to remind everyone that feminism is plural. And in that sense, all forms of feminism are to be accepted, and that diversity of tactics is a means to achieve our goals. That judging of associations' feminism is akin to reproducing society's patriarchal schemata. Furthermore, if associations are currently affiliated to ASSÉ, it's because they already have feminist demands, positions or practices or are in the process of obtaining them. Let us remind ourselves that it takes YEARS of struggle in order to change a culture or its, values, customs, norms, and traditions. And bearing in mind local sovereignty and other progressive values that are important to ASSÉ's members, local student associations have the right to self-management and self-determination, without the involvement of more influential associations or associations that are more advanced in their feminist realization.

With this in mind, AESPEP has produced its summary, in a positive manner. It means to encourage student associations' local initiatives that aim to adopt positions and to have feminist practices and demands, in a way that is respectful of their local sovereignty and therefore respectful of their realities and their struggles. AESPEP is submitting its summary, to possibly help associations get ideas for feminist positions, practices and demands.

# Summary of AESPEP's feminist demands, practices and positions

- AESPEP is in favour of free and consented sexual practices, and rejects any and all forms of sexual violence, be it physical or discursive.
- AESPEP condemns the use of slogans and/or signs and/or promotional videos and/or advertising that refer to sex in a degrading manner or that refer to rape.
- AESPEP is in favour and encourages equality between men and women, meaning that AESPEP pledges to develop feminist tools (such as feminization and promoting alternating between men and women in speech turns), to open spaces for feminist reflection among students in Political science and Philosophy, to support women's struggles and movements and to feminize its Bylaws and all of its communications.
- AESPEP is clearly and publicly in favour of the respect of all opinions expressed in its formal (GA, committee, etc.) and informal meetings between members of AESPEP, as long as these opinions don't include any hateful, racist, sexist, homophobic or transphobic content.
- Be it resolved that AESPEP remind the ASSÉ Congress that feminism is plural and that it implies diversity of tactics.
- Whereas AESPEP has pro-feminist positions; Be it therefore resolved that AESPEP pledge to include in the program's structure any new class dedicated to feminism in Political science and Philosophy so that it may be available as an elective.

### Article 18: Feminist Council

The Feminist Council is a decision-making body. In that sense, it can adopt positions on certain subjects and issue mandates to the Executive. Its decision-making power is however limited as it cannot adopt positions that don't concern the cause of feminism. The body is mixed in its deliberations, but non-mixed in its decision-making. Meaning that all members may deliberate, but voting rights are reserved to people of female sex or gender. The positions and mandates adopted in this instance have the same value as those adopted in General Assembly, but any decision impacting the bylaws must be ratified by the GA.

The minimum quorum for the Feminist Council is that a third of the participants are of female sex or gender and are members of AESPEP, or in the case that there are fewer than nine participants who are members of AESPEP, the quorum is of three people of female sex or gender. The Feminist Council must convene at least once during the fall semester and once during the winter semester, with a minimum notice of one week. It may be convened independently from the General Assembly and may also be convened within a GA under the condition that the GA specify that the Council will convene inside the GA. In any case, the Feminist Council must be chaired by a person of female sex or gender. Any member of AESPEP may request that the

Council convene. He or she must submit such a request to the president who then has three days to convene the Council, which must take place at in at least seven and at the most fourteen days after the convocation. All procedures not otherwise specified in the present article are the same as in a GA.

### Non-mixed caucus:

If the context requires it, people of female sex or gender may convene amongst themselves to discuss certain sensitive subjects, but may not adopt a position or resolution (except to waive the voting rights exclusivity for people of female sex or gender). The non-mixed caucus is convened as soon as a person of female sex or gender expresses the need for it. Discussions in non-mixed caucuses are based on good faith and must not be used as a means to exclude male members of AESPEP from the dialogue. Therefore, if the chairwoman considers that the request for a non-mixed caucus is done in bad faith, she may refuse the request. It is possible to appeal the chairwoman's decision through the regular procedures for doing so. Once back in mixed Council, the chairwoman must present a summary of the discussions that took place in non-mixity without disclosing any information that would undermine the anonymity offered by the caucus.

Waiving the voting rights exclusivity for women:

The Council may, if it deems it necessary, to give voting rights to all members of AESPEP on certain subjects according to the modalities it deems fit. Waiving the voting rights exclusivity for people of female sex or gender must be done by a 2/3 vote and must be decided in a non-mixed caucus.

# **SECMV'S SUMMARY**

(Submitted April 15th, 2016)

The SECMV Feminist Committee was created in 2007, and has endured many highs and lows since then. For several years, the Feminist Committee was relatively moribund, but several women organized themselves in order to put forward feminist practices and principles at SECMV, as well as in Cégep Marie-Victorin. It's important to understand that the Cégep's population is 75% female, and that feminism both in practice and in principle are at the heart of the student association.

Since fall 2015, the women of the SECMV Women's Committee have been particularly active. A safe space was furnished for female students. Meetings are held every week in order to organize among women and to create new projects. A feminist library was founded and is open to all students in the Cégep. A compendium of feminist texts and zines was also created.

The Feminist Committee also published a reflection text on the place of feminism at ASSÉ, following several problems with the provincial organization ("Critical reflection text on the ASSÉ Women's Committee and the place of feminism in our organization"). Different information materials were created on a variety of subjects, namely on sexist Halloween costumes, condemning sexist advertising, as well as creating a campaign on consent in collaboration with our self-managed student café, l'Exil. Workshops on topics such as the importance of non-mixity were organized in order to deconstruct prejudices surrounding such topics. Recently, the Feminist Committee took on an important project: organizing a feminist training camp which will take place on April 30th and May 1st. Finally, SECMV has several daily feminist practices, such as distributing free condoms, pamphlets on attitudes to avoid during parties as well as flyers on consent during all of our festive events. We also alternate between men and women in all our instances. We also promote the importance of feminizing written documents and speech turns during General Assemblies, committee meetings, Executive Council meetings and even between activists.

# Attached you'll find a list of demands adopted by our General Assembly.

Be it resolved that ASSÉ launch a campaign whose principle demands are (on the topic of student labour):

- Full wages for all students at any level doing an internship
- The abolition of parental contribution in the financial aid contribution
- Collegial management (between students, professors, and employees) of educational institutions
- The recognition of the value and the concrete use of student production by the implementation of such a program at both the Cégep and University levels
- <u>In the perspective of recognizing studies as intellectual labour worthy of wages and</u> of decent conditions.

Be it further resolved that the feminist aspect of this campaign and its demands be put forward, namely because the current financial aid format contributes in maintaining the patriarchal institution of marriage.

Be it further resolved that the anti-ableist aspect of this campaign and its demands be put forward, since students with special needs are particularly penalized by the obligation of balancing work and studies.

Be it further resolved that this campaign put forward the too-often despised reality of LGBTQIIAA+ students, for whom the actual student condition forcing them to live in sometimes tense situations with families who are opposed to the student's sexual freedom.

Be it further resolved that this campaign put forward the too-often despised reality of students in technical programs, for whom internships and financial aid have a greater

impact than University tuition fees, an issue that is constantly at the heart of the student struggle.

Be it further resolved that we study the possibility of including guaranteed minimum wage and/or the inclusion of students in this measure into our demands.

Whereas it's important that equality between the sexes be promoted in school settings; Whereas literature is an important instrument in reproducing social and cultural values; Whereas literary works written by women are underrepresented in school curricula;

Be it therefore resolved that SECMV be in favour equal representation between male and female authors in all Cégep-level required readings.

Be it further resolved that SECMV be in favour of feminizing post-secondary education.

Whereas the feminist movement is in constant evolution and encompasses several heterogeneous and conflicting feminists;

Whereas since the feminist movement involves taking position, the content of the taught class will be irremediably subjective;

Whereas it would be detrimental to women in the feminist struggle if a Ministry took charge of the creation of such a program;

Be it therefore resolved that SECMV oppose the creation of an institutionalized Cégep-level class on feminism.

06-05-2015

Be it resolved that SECMV demand the abolition of the (fictitious or actual) position of ASSÉ spokesperson, and that all communications with media be done by local spokespeople, alternating between men and women and between Cégep and University students.

01-04-2015

Be it resolved that SECMV condemn rape culture as well as all acts of sexual assault, abuse or harassment.

Be it further resolved that SECMV create safe spaces available to everyone in all events it organizes or takes part in.

Be it further resolved that SECMV not tolerate any slogan, action or discourse that legitimizes or trivializes rape.

Be it further resolved that SECMV support as best as it can any member wishing recourse against anyone or against an assaulter, keeping in mind that the survivors are in the best position to decide which is the most effective way for them to begin the healing process.

Be it further resolved that SECMV ensure that the recourses done by members against an assaulter in the context of transformative justice be respected within its instances and events that it organizes.

Whereas the 7th core principle and the sixth criterion 4 and 5 of the ASSÉ Bylaws are to be respected;

Be it therefore resolved that SECMV demand that ASSÉ respect its Bylaws.

Be it further resolved that, in that sense, SECMV demand that ASSÉ consider as non-member the student associations that don't have feminist principles, practices and demands unless they pledge to do so before the Annual Congress.

07-04-14

Be it resolved that SECMV support LGBTQ struggles (lesbian, gay, bisexual, trans, queer).

30-11-11

Whereas the question of access to education in feminism has and still continues to be very important;

Whereas problems related to gender equality often take place during periods of intense mobilization, such as a general unlimited strike;

Whereas the need for feminist information material, training and support in sustaining or creating local feminist committees has been felt among student associations;

Whereas a will to bring a feminist discourse into CLASSE's discourse, mobilizations and actions has been manifested;

Whereas the feminist movement is, as much as the current struggle, a combative one;

Be it therefore resolved that CLASSE integrate a Feminist Committee, of which the members of the Women's Committee would be de facto part of.

The Committee's functioning: The Feminist Committee will, during the Coalition period, be a committee in support of the ASSÉ Women's Committee. The Feminist Committee will include collaborators [male and female] that are not under the obligation to be elected by Congress, but who must submit a letter to Congress signifying their membership. They remain accountable to Congress. The mandate of the Committee is to:

- Organise feminist actions;
- Train feminist spokespeople;
- Create feminist mobilization material;
- Publish feminist texts or articles:
- Ensure feminism's visibility during demonstrations.

18-02-09

Be it resolved that SECMV propose that feminism not mandatorily be a demand in every ASSÉ campaign, but that its analysis be included globally, should the topic relate to it, as much as any other related factor (social, economic, etc.).

Be it further resolved that SECMV support the WOMEN-FAMILIES committee in its demands.

#### **RESUL'S SUMMARY**

(Submitted April 19th, 2016)

Here you'll find a list of feminist mandates and demands adopted by RESUL's General Assembly, as well as a list of concrete feminist practices that apply the said mandates.

#### Mandates and demands adopted by General Assembly:

#### Position 18

Be it resolved that RESUL be in favour of promoting that teaching should consider:

- Relevant feminist approaches to the studied subject matter (equal to any other field deemed relevant).
- The historical participation of both sexes with regards to the development of the studied subject matter (for example: through feminist content and a feminist bibliography).
- The "bad habits" that have been accumulated throughout history regarding shortcuts in the use of language or expressions, as well as solutions in order to avoid or resolve them (For example: when instead of "Humankind", we say "Mankind".).

#### **Position 19**

Be it resolved that RESUL be opposed to the use of terminology or vocabulary that overshadow one sex or the other or that don't respect scientific neutrality.

#### Position 20

Be it resolved that RESUL be opposed to any and all forms of advertising that promote a standardized female or male body, namely those employed or broadcasted by capitalism and patriarchy.

#### **Position 21**

Be it resolved that RESUL be opposed to the commercial exploitation of one's image, namely in advertising.

#### Position 22

Be it resolved that RESUL be in favour of equal wages as well as equality for social benefits related to being a parent.

#### Position 23

Be it resolved that RESUL be in favour of free contraceptives.

#### Position 24

Be it resolved that RESUL be in favour of abortion rights as well as its economic, political and geographic accessibility.

#### Position 25

Be it resolved that RESUL be opposed to the promotion of the heterosexual couple as an ideal model for sexual orientation, and that it be opposed to any and all benefits (economic or social) granted to couples.

#### **Position 32**

Be it resolved that RESUL support the UL Women's Committee in its efforts to implement feminist popular education and to broadcast its projects and activities related to feminist issues;

Be it further resolved that RESUL donate a \$40 photocopy card to the UL Women's Committee:

Be it further resolved that RESUL call on other associations to support the UL Women's Committee:

Be it further resolved that the Executive place a pot for contributions at the RESUL office as well as during events and that all proceeds be given to the UL Women's Committee.

#### **Position 39**

Be it resolved that RESUL be opposed to heteronormativity and that it support LGBTQIA struggles as well local (University) initiatives opposing the binary categorization of gender.

#### **Practices:**

Here is a list of practices that are always in place at RESUL:

- Feminization of speech and of written communications;
- Alternating speech-turns between men, women, and non-binary people during GA's and Exec meetings;
- We encourage non-mixity in all our instances;
- Presence of a mood watcher during our GA's.
- Equal representation in our Executive (there are even more women than men).
- Encouraging feminist initiatives on campus.

Since our association only has about one hundred members, it's impossible for us to have our own Women's Committee.

Since there are many diverse feminist initiatives on campus and that RESUL members can participate in them (conferences, café-discussions, non-mixed discussion circles), RESUL considers that encouraging these initiatives is sufficient in order to favour feminist reflection and discussion on campus.

#### Reflections regarding the notice of motion:

This notice of motion could be an excellent occasion for collectively thinking about our feminist positions and practices within our instances and on campus. We consider this reflection to be important and one that must be frequently renewed. Therefore, we're grateful for this opportunity, although it could've been brought in a different way. That being said, we consider our feminist practices to be sufficient.

Keeping in mind the particular context that is Quebec City, where mobilization in a broad sense is less active and where values such as feminism are less promoted, we consider that encouraging existing initiatives is sufficient, since in any case, the same women would be the ones holding the torch in different instances, which would mean a significant increase in their workload.

It'd undoubtedly be beneficial if every association were as active as the ones in Montreal, but one must understand local realities and respect as well as encourage these localities when adopting new practices and mandates. Rather than seeking to understand associations' dynamics, we consider that AFESH is institutionalizing a domination dynamic between itself and other associations, which contributes in excluding associations from outside Montreal.

Be it resolved that RESUL be in favour of equal wages as well as equality for social benefits related to being a parent.

(23-03-2016)

Be it resolved that ABEILL be in favour of free contraceptives, and that it be opposed to taxation of feminine hygiene products.

(23-03-2016)

Be it resolved that ABEILL be in favour of abortion rights as well as its economic, political and geographic accessibility.

(23-03-2016)

Be it resolved that ABEILL recognize the intersectionality and the plurality of feminist and

LGBTQ+ struggles, meaning the diversity of material conditions and social, economic, political, geographic, and spiritual contexts surrounding different realities and demands. (23-03-2016)

#### 2. Practices and accomplishments

First of all, when reforming the Bylaws last year, ABEILL recognized the necessity of having a mood watcher during its General Assemblies and, therefore, added such a position to its praesidium. Also, we alternate between men and women during speech turns in GA's. Furthermore, although it's not enshrined in its Bylaws, ABEILL has had over the past years (or at least in the past three and also next year), an Executive Council composed mostly of women. The Executive also feminizes its speech and written documents, and promotes this practice among its members.

Feminist activities are organized by ABEILL's Mobilization Committee since it doesn't have a Women's Committee and due to difficulties in reaching students. Also, the UL Women's Committee was pretty active over the past year and ABEILL's Mobilization Committee has always invited its members to the events and conferences that are organized. Recently, ABEILL's Mobilization Committee organized a "trust event" dealing with feminist and Queer events as well as domination dynamics. This event also included a presentation on the history of the different feminist and LGBTQ+ movements. We also explained some lesser known concepts and explained the importance of non-mixed discussion groups. We then did a presentation on domination dynamics and then, in break-out groups, did a game where one person mimed the dynamic and the others had to guess it.

#### FASA'S SUMMARY

(Submitted April 20th, 2016)

#### **Motions adopted in a General Meeting:**

Be It Resolved That FASA reiterate its position for a combative feminism towards the abolition of the patriarchal system, against all forms of oppression and discrimination.

BIRFT FASA favor, in its structures, the empowerment of women, towards a complete gender equality, by the creation of non-mixed caucuses and the implementation and full support of a Women Committee, under the responsibility of the Mob Squad.

BIRFT FASA make it mandatory for all its coordinators and for one representative of every clubs and affiliates to attend a workshop on consent and the effects of sexual and gender-based violence.

BIRFT FASA invites all other student associations of Concordia and the administration of Concordia to make this workshop mandatory for every student leaders.

Adopted at the 2015 AGM

Considering the motion notice deposited by AFESH (Social Sciences UQAM student association) to be considered at the Annual ASSÉ Congress the 16th-17th of April 2016;

Considering that this motion calls on certain targeted member associations of ASSÉ to publicly prove their feminist positions, principles and practices;

Considering that this motions calls for the exclusion of any associations who fail to adequately publicly prove their feminist positions, principles and practices;

Be it resolved that FASA oppose the divisive nature of this motion which creates a division and a hierarchy of 'most feminist' and 'least feminist' associations;

Be it resolved that FASA encourage the sharing of resources and information between member associations of ASSÉ in order to favor the growth of local feminist mobilization across CEGEP and University campuses;

Be it resolved that FASA invite its membership to partake in feminist activities organized by ASSÉ and its member associations in order to continue fostering feminist culture and debate within FASA;

Be it resolved that FASA publish a report summarizing its feminist principles, practices and points of future improvement and disseminate this report over ASSÉ-support (internal mailing list of ASSÉ) in the desire to inspire and enhance collaboration between member associations around feminist issues;

Be It Resolved That FASA reiterate its position for a combative feminism towards the abolition of the patriarchal system, against all forms of oppression and discrimination.

BIRFT FASA favor, in its structures, the empowerment of women, towards a complete gender equality, by the creation of non-mixed caucuses and the implementation and full

support of a Women Committee, under the responsibility of the Mob Squad.

BIRFT FASA make it mandatory for all its coordinators and for one representative of every clubs and affiliates to attend a workshop on consent and the effects of sexual and gender-based violence.

BIRFT FASA invites all other student associations of Concordia and the administration of Concordia to make this workshop mandatory for every student leaders.

By encouraging feminist dialogue within the field of art, we strive to examine representations of women, raise questions in relation to the art historical canon and foray into the realm of gender exploration.

#### **Queer Print Club**

The Queer Print Club is a student-run Concordia University fine art print media collective of queer, lesbian, gay, trans\*, two-spirited, bisexual, asexual, intersex, questioning, and allies. Members of the club include Concordia students enrolled in Print Media classes. QPCC is a branch of SPA (Student Printmaking Association, Concordia).

The QPC aim to create a non-hierarchical space to discuss, share ideas and make together (or apart) zines and other print projects. Their projects mostly explore the collaborative, community-based and democratic aspects of print as well as creating a space to fuel personal projects.

# APPENDIX 1 : MOTION TO MODIFY APPENDIX I OF THE ASSÉ BYLAWS

(Submitted by the Coordination Council)

APPENDIX I: ARREST FUND

**Article A27: PRINCIPLES** 

The Fund exists in solidarity with those who are arrested in the context of demonstrations and actions that are in accordance with the principles and demands of ASSÉ, as well as those who are facing administrative or disciplinary measures by their educational establishment's administration, regardless of their role or political position in the organization. The Fund considers that all activists arrested in the context of the student struggle have the right to logistical, human and financial support. The ASSÉ Legal Committee seeks to respond to every need expressed by these people and considers that no one should be forced to plead guilty for reasons of financial need.

#### **Article A28: CRITERIA**

The Fund is primarily destined to people who have been arrested in the context of protests and actions that are in accordance with ASSÉ's principles and demands, as well as those who are facing administrative or disciplinary measures by their educational establishment's administration, and who have made contact with ASSÉ's Legal Committee.

Financial resources are allocated to people who request it according to the following order of priority:

- 1. People facing criminal charges, particularly those that could lead to imprisonment;
- 1.1. Individual trial: in the case of Legal Aid being refused, the Fund covers all costs related to the defense. Regarding Contributory Legal Aid, the Fund covers the cost of the requested contribution;
- 1.2. Collective trial (mass arrest leading to criminal charges or individual arrests leading to criminal charges in the context of a single event): the Fund's support is determined according to, among others, the following criteria: the amount of people arrested the amount of Legal Aid mandates the amount of lawyers representing the group the length and complexity of the case;
- 2. People who are facing administrative or disciplinary measures by their educational establishment's administration, such as expulsion of threats of expulsion;

- 3. People facing penal charges (e.g.: tickets, mass arrests);
- 4. People who targeted for their role in political organizing.

Considering the transformation and expansion of the forms of repression, the ASSÉ Legal Committee has a certain degree of flexibility in the application of its mandates, which is oriented towards the preoccupation of offering its support to people who are targeted by new forms of repression.

When evaluating requests for financial aid, the Committee considers the following criteria:

Other resources (Legal Aid, local associations, etc.) people have access to;

The risks for targeted individuals and the impacts on their lives;

Political profiling;

Equity among requests;

The impact of a legal decision on current struggles;

Other considerations.

#### **Article A29 : EXPENSES COVERED**

This list applies to people who are representing themselves as well as people represented by a lawyer.

- 1. Bail;
- 2. Lawyers' fees (a prior agreement with the Legal Committee is required);
- 3. Legal fees (transcripts, etc.);
- 4. Logistical fees (transportation to the venue, etc.);
- 5. Access to information requests;
- 6. Other defense-related expenses.

In cases of emergency only, a loan may be done to a person in order to avoid any important consequences related to their prosecution (e.g.: paying a fine after a plea of guilty or a verdict of guilt).

#### **Article A30 : CONFLICTS OF 'INTEREST**

Lawyers cannot be elected to the Legal Committee. Members of the Legal Committee must declare to the other members of the Committee any actual or apparent conflict of interest related to any decision. Members of the Legal Committee must recuse themselves from any decision in cases where an actual or apparent conflict of interest may arise. The Legal Committee is accountable to ASSÉ's instances at all time.

The Committee approves of the Bylaws enacted above and ensures their application. It must receive and rule on funding requests for legal defenses. It is also authorized to reimburse accrued expenses, solely upon presentation of receipts.

## APPENDIX 2 : CURRENT VERSION OF APPENDIX I OF THE ASSÉ BYLAWS

(Submitted by the Coordination Council)

APPENDIX I : ARREST FUND

**Article A27: Principles** 

The Fund exists in solidarity with those who are arrested in the context of demonstrations and of the student struggle, regardless of their role in organizing the demonstrations or of their political position. The Fund considers that all activists arrested in the context of the student struggle have the right to logistical, human and financial support. The Committee considers that no one should be forced to plead guilty for reasons of financial need, and it seeks to respond to the needs of all those who have been arrested.

Article A28: Criteria

The Fund is primarily intended for people arrested during student demonstrations and who make contact with ASSÉ's legal committee in accordance with the following criteria.

Money will be distributed according to the following order of priority:

- 1. To those facing criminal charges that could lead to imprisonment;
- 2. To those without access to other sources of funds (legal aid, local associations, etc.);
- 3. To militants targeted for their role in political organizing.

#### **Article A29: Expenses covered**

- 1. Transportation to the venue;
- 2. Legal fees (transcripts, etc.);
- 3. Bail;
- 4. Logistical costs;
- 5. Access to Information requests;
- 6. Lawyers' fees (a prior agreement with the Legal Committee is required);

7. Other expenses linked to legal costs.

#### **Article A30 : Conflicts of Interest**

Those who are accused and lawyers cannot be elected to the Legal Committee. The members of the Committee must recuse themselves from meetings in situations where they might have conflicts of interest of another kind. The ad hoc Legal Committee acts autonomously but answers at all times to ASSÉ's Congress. The Committee approves the Bylaws enacted above and ensures that they are implemented. It must receive and rule on funding requests for legal defenses. It is also authorized to reimburse accrued expenses, solely upon presentation of receipts.

## APPENDIX 3 : MOTION FOR A NEW CHAPTER 5 OF THE ASSÉ BYLAWS

(Submitted by the Executive Council)

#### **CHAPTER 5: COORDINATION COUNCIL**

#### **ARTICLE 20: COMPOSITION**

The Coordination Council is made up of the following delegations: the Executive Council, the Committees and the active Councils, and the member associations. Every delegation can count up to three persons with at least one woman or one non-binary person if the delegation is made up of two or three persons. Every delegation has a right to vote and propose but only the Executive Council, the Regional Councils and the Committees have the right to vote.

#### ARTICLE 21: AIMS AND FUNCTIONS

The Coordination Council aims to coordinate the national campaigns. It is responsible to put in motion, assisted by the Executive Council, the Congress' decisions. It also has the following duties:

- 1. Produce a report of its activities to every Annual Congress;
- 2. Promote ASSÉ and student unionism;
- 3. Insure and improve the internal cohesion of ASSÉ;
- 4. Supervise, assist and insure the well-being of the Executive Council and the Committees.

#### **ARTICLE 22: POWERS**

The Coordination Council is responsible of ASSÉ's decision making process in-between Congresses although it cannot in any case make decisions regarding affiliations, suspensions, expulsions, the Bylaws, membership dues or ASSÉ's dissolution. Any decision made by the Coordination Council must be made in conformity with the Congress' general political and ideological orientations. It can precise and add content to existing resolutions but cannot adopt new ones. It can precise and add content to the existing action plan but cannot adopt a new one. The Coordination Council cannot come back on any decision made by the Congress but the Congress can come back on decisions made by the Coordination Council. Every Regional Council has a veto to bring any subject to the Congress.

The powers administered to the Coordination Council are the followings:

- 1. Make recommendations and propositions to the Congress;
- 2. Create ad hoc committees to help its work;
- 3. Insure the execution of the decisions made by the Congress;
- 4. Resolve any dispute between ASSÉ and its many bodies;
- 5. Define the tasks assigned to the Committees.
- 6. Appoint an interim member of the Executive Council or the Committees until the next Congress;
- 7. Relieve of its functions any individual it has appointed.

#### **ARTICLE 23: QUROUM**

The quorum is set at 50%+1 of ASSÉ's Committees and active Councils.

#### ARTICLE 24: SECRETARY-GENERAL

There is one (1) Secretary-General of the Coordination Council. It is elected in Congress in accordance with the usual election procedure.

It has the following duties:

- 1. Share to ASSÉ's members the summon to the Coordination Council and insure the participation of the summoned delegations;
- 2. Prepare the agendas and preparation booklets of the Coordination Council meetings;
- 3. Supervise the execution of the mandates given by the Coordination Council to the Committees and Councils:
- 4. Make follow-ups regarding the decisions made by the Coordination Council;
- 5. Assist the Committees and Councils if needs be.

#### **ARTICLE 25: CONVENING**

The Coordination Council has to be convened at least once a month with a maximum of 45 days between each meeting. It may be convened by itself, by the Secretary-General or by the Executive Council if the two others are not capable of doing so. In the case where the Executive Council is the only abled body to convene a Coordination Council, it may do so in a minimum of

14 days.

In the event of an extraordinary meeting of the Coordination Council, it has to be convened by at least three Committees or Councils. To do so, a written demand must be sent to the Executive Council who will then convene a meeting in the next 5 days following the demand.

The Coordination Council is convened through ASSÉ-Support in a message including the preparation documents, the minutes and the link to the video-conference.
